I was blessed to get into the Drug Court program because my life is now on the right track...Drug Court is challenging, but it is much better than the alternative...I've gone from addiction to recovery and not many addicts get a chance to experience what I've experienced. 2009 Program Accomplishments

Resonance served an unduplicated total of 898 women.

Among them:

- ♦ 34 women graduated from Drug Court.
- ♦ 425 women received community counseling.
- ♦ Approximately 125 women participated in job counseling.
- ♦ 4 were trained in valuable job skills by CERTIRestore.
- ♦ 42 girls attended the Girls Unlimited summer sessions.
- ♦ 268 women were served by TANF, case management, and other Resonance programs.

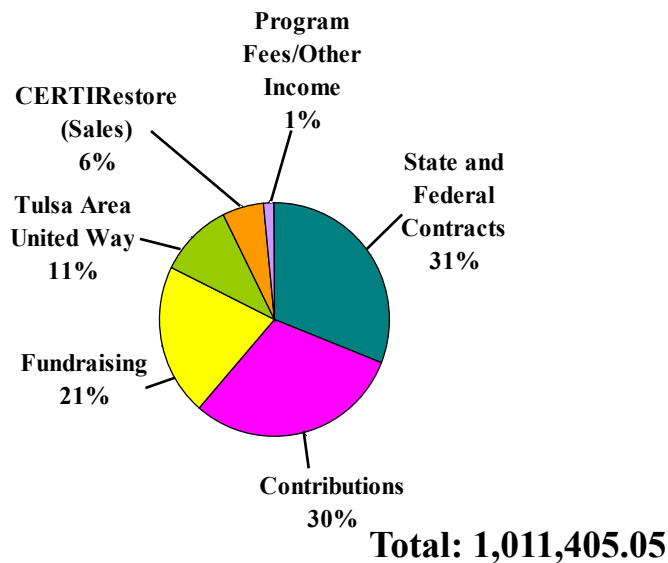
Conservatively, every woman we serve impacts *at least* five people in our community.

When our donors *touch the life of one woman*, the impact is fivefold.

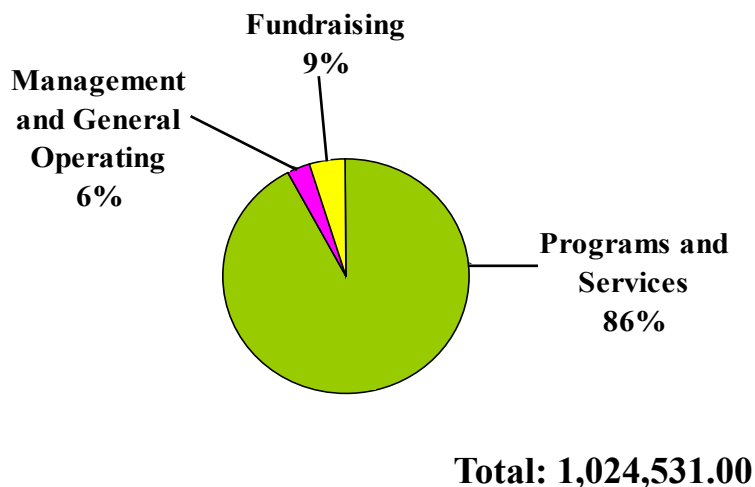
898 women served x 5 lives = 4490 lives positively influenced in 2009!
